SECTION 4: First aid measures

4.1 Description of first aid measures

General notes

Wear suitable gloves. Check leak-tightness/impermeability prior to use. For special purposes, it is recommended to check the resistance to chemicals of the protective gloves mentioned above together with the supplier of these gloves. The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. - breakthrough times of the glove material
